#### **COURSE DESCRIPTION**

Examine the police role and law enforcement policy, police organization, personnel issues, management, and operations, as well as coordination and consolidation of police service, police integrity, and community relations.

# M.A. Criminal Justice Program Learning Goals

We link our students to real-world issues and practices to promote careers of impact in a range of public and private organizations that deal with crime, justice, and their consequences. This is achieved through a rigorous grounding in policy, theory, and analysis that involves the following competencies:

# Policy skills

Students will develop knowledge of criminal justice system operations and key
debates in the field to become informed criminal justice policy analysts. This will
be achieved through a comprehensive training encompassing the review of
substantive approaches to the structure and change of criminal justice
organizations as well as in-depth case studies centered on issues of
management, resource allocation and innovation.

# Problem-solving

 Students will learn how to identify and measure crime and criminal justice policy problems using appropriate methodological and statistical techniques. They will also learn how to design appropriate targeted interventions to respond to these problems, and techniques of monitoring and evaluation to track the success of interventions.

#### Integrity

Students will deepen their sense of responsibility and commitment to the criminal
justice field and the communities affected by criminal justice policies. They will do
this by learning to bridge gaps between policy, research and theory, and to
appreciate the social context of criminal justice policies and both their intended
and unintended consequences.

#### Leadership

Students will develop the confidence and vision to become agents of change
within criminal justice agencies, social service organizations, and communities
impacted by criminal justice policies. This will be acquired through hands-on
experience(s) working in the field, and learning ways to design and advocate for
solutions to crime and criminal justice problems.

#### **Course Learning Goals**

1. Explore and critique different philosophies and perspectives around policing

- 2. Develop an understanding of history of policing and the use of innovations, programs, and technology to address challenge areas in policing.
- 3. Develop critical thinking and assessment of issues related to policing.
- 4. Develop written and verbal communication skills.

Supplementary Materials will be available in Canvas.

# III). Course Assessments/Evaluations

The final grade will be assessed based upon your performance on the following: 2 exams (worth 40% of your final grade), 2 short writing assignments (worth 20% of your final grades), one research presentation (20% of your final grade), and discussion boards (worth 20% of your grade).

# **Grading Policy**

Each assignment has a specific due date and time which is listed in Canvas. Assignments (e.g., Discussion Boards, Reflection Papers, and Exam 1) are due on Friday at 5:00pm assigned for the week (it is strongly advised to submit work early, and not wait until the last minute). The due date of Friday at 5:00pm is used for all assignments/exams (except Exam 2) and is utilized so that the instructor may provide grading in as close to real time as possible.

**Exams:** There are 2 exams each worth 20% of your final grade (total 40% of your final grade)

- There will be 2 exams that will consist of a series of 4 essay questions.
- There are no review sheets provided for the exams (as this is a graduate course).
- Exams will be open book and open note.
- Exams will be remote via Canvas (see course schedule)
- Questions will be conceptual and applied in nature.
- Students are responsible for knowing all assigned readings and lecture material.

\*Supplementary materials will generally not be included on exams.

#### 2 Short Writing Assignment Papers (Reflection Papers) 20% Total (10% each):

- Reflection Paper 1: Al Identified Policing Challenge Area. For this assignment the student is to ask an Al (e.g., Chat GPT) to write a 4–5-page 1000-to-1250-word (double-spaced, one-inch margins, Times New Roman, font size 12, page numbers) challenge area for policing. Students are to then write a 1000 to 1250-word critique of the Al's response (double-spaced, one-inch margins, Times New Roman, font size 12) students are free to critique the paper as they see fit, but areas to critique are area of focus (e.g., do you agree or disagree with the area the Al identified as a Police Challenge Area, accuracy of the information, etc.)
- Reflection Paper 2: Review of the Film Fallen: Students are to watch the film Fallen (see link in Canvas) and write a review of the film. The review should be 5 pages word double-spaced, one-inch margins, Times New Roman, font size 12) and should focus on how the film influenced the students view of law enforcement as a profession

<u>Students must include an APA Style Reference page and include in-text citations</u> for any sources used for the Reflection Papers

Discussion Board Participation 20% (there are 10 discussion board assignments worth 2% each)

<sup>\*\*</sup>Please note there will be no make-up or late submission for Exam 2.

- Discussion boards consist of an activity (e.g., watch a video, read an article, respond to a question) in which the student will be required to post a primary posting of their own response, and 1 response to another student.
- Students are encouraged to record audio or video presentations.

Research Presentation & Related Assignments (20% of your final grade): For the research presentation, you will choose a topic related to policing. More information will be provided on Canvas. Throughout the semester, you will make progress on your research presentation and turn in assignments related to your research presentation topic (5 points), research presentation references (5 points), research paper presentation and outline (5 points), rough draft of the research presentation (slides only) (10 points) and the final presentation (75 points). The research presentation is to be recorded and uploaded to Canvas for viewing/grading.
