#### **COURSE DESCRIPTION**

This course is for Masters level students who have completed the Problem Analysis and Planning and Evaluation courses. The class is designed as a workshop/seminar in which students apply the skills learned in these classes to a final Masters project. The project is a criminal justice research endeavor led by the student, and facilitated by the professor. Projects will take different forms, depending on each student's interests, prior experiences in the field, or internship placements.

The class will largely be student directed, with the professor serving as a facilitator for problem solving and completion of the projects. Students are expected to be engaged and self-directed, working independently, and seeking assistance from the professor and other faculty members as needed.

# SUMMARY OF COURSE REQUIREMENTS AND GRADING

This is a 3-credit course. You will receive a letter grade. It is designed to be hands on and interesting, allowing you to apply much of what you've learned during your time at the School of Criminal Justice. We will discuss potential projects in early course meetings. The final product will be analytical rather than descriptive in nature, and will not be a literature review type paper. Students will complete human subjects research training through the Rutgers University Institutional Review Board (IRB), propose their research projects to the IRB, and ultimately receive approval through Non-Human Subjects Research designations. **IRB approval must be granted prior to gathering data.** Students will submit progress reports throughout the semester. The course will culminate in the submission of a final paper and presentation of research findings.

# In order to receive a satisfactory grade, you must meet the following course requirements:

Successfully pass the Rutgers IRB Human Subjects Training modules (Collaborative Institutional Training Initiative).

Receive approval for your study from the IRB through the Non-Human Subjects Research designation.

Attend course meeting sessions.

Submit proposal and progress reports as indicated on the meeting schedule.

Attend scheduled meeting(s) with the professor.

Present results of your study.

Submit the final Masters project you propose.

#### CLASS PROCEDURES AND EXPECTATIONS

Class sessions will follow a seminar format with a great deal of participation. You are expected to be prepared to participate in class, and to treat other class members with courtesy and consideration.

We will meet as a group three times. Once in the beginning of the semester to orient the class, once in the middle of the semester to share progress with the group and receive feedback, and once at the end of the semester to make formal Power Point presentations about research findings. We will have an individual meeting (likely via Zoom) during the second week of the semester to discuss project ideas and research interests. Other individual meetings will take place as necessary throughout the semester. Both group and individual meetings are mandatory requirements for the course.

Prior to starting your project, you are required to pass the Rutgers University
Collaborative Institutional Training Initiative (CITI) Basic Course. Log into the CITI
program with your Rutgers NetID and Password. This training course familiarizes
researchers with appropriate protocols for conducting research that involves human
subjects. Proof of successfully passing the training shall be submitted to the professor at
the first individual meeting session in the second week of the semester. The specific
course that you need to pass is called "Social / Behavioral / Epidemiologic Research
Investigators." Students should submit their PDF certificates of course completion to
Canvas.

The Masters Project Seminar course serves as a classroom exercise to familiarize students with the process of conducting applied research projects. As such, **students will not be able to use or present findings from projects outside of the class.** Additionally, student projects shall not include vulnerable populations such as imprisoned people or children, **and will pose no more than minimal risk to potential participants**.

To ensure that projects are approved by the IRB in a timely fashion, students should seek determination of their research to be "Non-Human Subjects Research." <u>Students must login to the Rutgers University eIRB</u> to propose a study and select "Non-Human Subjects Research (NHSR)" as the submission type. When asked whether your project qualifies as research ("Does the proposed activity constitute research according to the federal definition of research") – you are answering "No" because this project is an in-class exercise to learn about the research process, and you are not contributing to a generalizable knowledgebase.

A one-to-five-page proposal is due near the beginning of the course, and sections of the final paper are due throughout the semester. Specifics about what to include in the proposal are presented in the schedule below and will be covered in the first class session. The proposal shall be submitted to the professor and will be used by students for their research summaries to get IRB approval through the Non-Human Subjects Designation.

Progress reports should reflect an approximation of a final product for each respective section. Follow standard rules about documentation and citation. If you are unsure about how to properly cite, please contact the professor for guidance and use helpful guides such as the one found here.

The final paper is due at the end of the semester on **December 15**. The professor must approve any deviations from the proposed project. Final papers should be of a graduate thesis level in quality and between approximately 25 and 30 pages in length.

You are responsible for all announcements and class proceedings. If you miss a class it is your responsibility to obtain notes, handouts, and announcements as soon as possible. The class schedule is subject to change with appropriate notice from the instructor.

All assignments, accept for the Power Point presentations at the end of the semester, are to be submitted via Canvas by 11:59pm on the date on which they are due. Submit your Power Point presentation to Canvas by 5:00pm on December 8 so that I can prepare for the in-person presentations that day. Late assignments will not be accepted.

# Week of September 15: CITI Training Completion

- 1. Go to the CITI website and take (and pass) the course "Social / Behavioral / Epidemiologic Research Investigators"

## September 22: Proposal (~1-5 pages)

- 1. An introduction to your project.
- 2. A statement of why the proposed research is important and addresses a criminal justice problem of interest.
- 3. A brief description of your proposed methodology(ies).
- 4. A statement about the subjects of your research.
- 5. A concluding paragraph with a summarization.

# By September 29: Non-Human Subjects Research Application to IRB should be complete

- 1. Go to the eIRB website and propose a new study under the "Non-Human Subjects Research" type. Submit a synopsis of your research to the IRB. When asked about whether your research meets the federal definition of research you are answering "No" because this is strictly an in-class research exercise, and students do not use results outside of the class. If students need additional help with crafting their research synopses for the IRB, the DRAFT services team can help (in addition to the professor). The DRAFT team typically hold Zoom office hours on Tuesdays and Thursdays, and are responsive to emails.

#### **Progress Reports**

## October 13: Introduction and Literature Review (~8-10 pages)

- 1. Introduce the subject/problem that you are exploring in your research.
- 2. Communicate the purpose, goals, and objectives of the proposed project and demonstrate its importance.
- 3. Review and evaluate relevant literature to demonstrate awareness of the state of current research in your problem area. Look for reviews that summarize a field (Annual Review papers for example) or meta-analyses as well as original research communicated in academic journal articles.
- 4. State how the project is expected to contribute to our collective understanding of your topic area.

## **November 3: Research Questions and Methodologies (~6-10 pages)**

1. State the central research question(s) and any hypotheses (precise, testable). Describe your research design (i.e., description of the method(s) you will use to collect data) and provide precise details on how you will collect the data. Describe the population of interest, the sample, and the sampling technique that will be used. Discuss measurement and analysis.

# November 24: Results, Discussion, and Conclusions (~8-10 pages)

- 1. Write about the results of your study and describe your findings. Use graphs, tables, and figures as necessary.
- 2. Describe the implications of your project for practice and policy. How will the broader criminal justice system benefit from your research project? What benefits will the research provide participants, those connected to them, and their communities?
- 3. Conclude your study with a summarization of findings, a reflection on prior work in the field of study you chose (i.e., your literature review), and how your project adds to our knowledge.
- 4. Review potential limitations of your study, and provide advice about how to address these limitations in future research.

## **December 8: Power Point Presentation of Research Findings (~15 minutes)**

- 1. Present your research projects to your peers.
- 2. Presentations should be about 15 minutes in length and cover the totality of your projects: the introduction, brief synopsis of the literature in the area, your research questions, methodologies, results, discussion, and conclusion.

#### **December 15: Final Assignment (~25-30 pages)**

A revised proposal that integrates all of the revised progress reports into a coherent package.

#### **Submission Guidelines**

Language Statement: The Rutgers University School of Criminal Justice (SCJ) encourages students, faculty, and staff to use person-first and humanizing language in their verbal and written communications. Being mindful of the ways in which we describe people impacted by our criminal legal systems is an important step in restoring their dignity and humanity. This evolution of language is an important piece of broader systemic shifts that are needed to make our justice systems more equitable. We encourage replacing labels that refer to people as "offender," "inmate," "parolee" or related labels with more neutral descriptors such as "person convicted of a crime," "incarcerated person," and "person under parole supervision." Formatting: All assignments must be submitted on Canvas. Use Times New Roman 12-point font, double-spaced, and left-justified only. Use in-text citations and follow American Psychological Association (APA) guidelines (e.g., Smith, 2021). All progress reports require a set of references that follow APA guidelines. Writing: The SCJ will hire a writing tutor in October. **Deadlines:** Contact the instructor at least three days before an assignment is due if you are struggling to meet a deadline. Extensions are rare but may be provided on a case-by-case basis given extenuating circumstances. Late assignments receive a .25 penalty for each day late (e.g., a paper graded as 9/10 would receive 8.75).

Include title, synopsis and purpose of project, aims and goals, proposed research methodologies, methods by which subjects will be accessed and consent procedure (if applicable), and methods for ensuring the anonymity of research subjects.

This proposal will help with your research summary to be submitted to the Rutgers IRB for approval to conduct your research project.
